#### 1.0 Event Details

- **1.1** The **Event** will run from 3 November 2023 at 19:00PM (SGT) until 3 November 2023 at 22:00PM (SGT) ("**Event Duration**") at Terminal 3, Arrival Hall, Level 1 (near McDonald's). Booking of slots for the Event is free-of-charge for existing Changi Rewards members.
- **1.1** Limited slots are available, on a first-come-first-serve basis and booking is exclusive to existing Changi Rewards members only.
- **1.2** Registration begins from **6:00PM (SGT)** ("Registration Time").

#### **2.0 Carnival Credits Terms and Conditions**

#### 2.1 Free Carnival Credits

Carnival Credits are strictly non-refundable. Exclusively for the **Event**, each event guest will receive 10 free Carnival Credits. Changi Rewards members are allowed to bring up to 3 guests. Members to exchange all free Carnival Credits to physical Carnival Tokens at the Changi Rewards Registration Booth on 3 November 2023. The physical tokens shall be valid on 3 Nov 2023 only, for members to access activities at Changi Festive Village. Additional purchased credits <u>are valid till 31 March 2024</u>, the last day of Changi Festive Village.
